THE HELENA M. BURROWS LEGACY SOCIETY

Upon Helena M. Burrows' death in 1962, she made a gift through her will (bequest) in the amount of \$100,000 for the construction of a nursing home. In addition to funds raised by the Utica Presbytery, the original Presbyterian Home was born.

From the initial 80-bed facility in 1964, we've grown into a multi-level healthcare community serving nearly 700 people a day. Presbyterian Homes & Services is a full family of senior care, from independent living to skilled nursing, a wellness center, rehabilitation services, a dedicated Parkinson's unit, and more.

We couldn't have done it without Helena's gift, and we can only continue it with yours. Those who name the Presbyterian Homes Foundation as a beneficiary of their estates, set up a gift that pays income back, or create an endowment are honored as members of the **Helena M. GIFTS THAT COST NOTHING TODAY

A GIFT THROUGH YOUR WILL OR LIVING TRUST

Want to designate a portion of your estate to the Presbyterian Homes Foundation? There is no minimum amount required. Just some thoughtful planning on where you'd prefer to see your legacy begin.

A will or living trust that includes the Presbyterian Homes Foundation as a charitable beneficiary is no different than any other designation, except that it includes bequest language. You can name the Foundation for a specific dollar amount, a set percentage of the total value of your estate, or the remainder of your estate after you have provided for your family. We suggest you provide this model language to your estate planning attorney:

I give and devise to the Presbyterian Homes Foundation, Inc. located in Oneida County, New York, Tax Identification Number 13-3348349, the sum of \$_____ OR _____% of my residuary estate, OR the

rest, residue and remainder of my estate to be used for its general purposes (or for the support of a specific affiliate or program you name).

A GIFT THROUGH YOUR RETIREMENT PLAN

You can designate a portion of your retirement plan to go to the Presbyterian Homes Foundation. Qualified retirement plans such as Individual Retirement Accounts (IRAs), 401(k)s, 403(b)s, and Keoghs may represent a disproportionate percentage of your net worth. By naming "Presbyterian Homes Foundation, Inc." on the change of beneficiary form for your retirement plan, you can designate the Foundation to receive a percentage of the funds left in the account at your passing. This option also has great tax advantages. If your qualified plan assets pass to someone other than your spouse at your death, they may be subject to both income and estate taxes. For some, this can result in more than 70% of the account's value going to the government in taxes. When the Presbyterian Homes Foundation or other charities are designated as the beneficiaries, no income or estate taxes are due at all! You can also direct how the proceeds from your retirement plan are used.

A GIFT USING YOUR LIFE INSURANCE POLICY

As you go through life, your insurance needs are constantly changing. Certain policies (for example, those to provide for children's education or to pay off the mortgage) are often no longer necessary. You may find that you can use the remaining value in these policies for charitable gifts in support of the Presbyterian Homes Foundation.

BENEFICIARY DESIGNATION

If you no longer need the entire death benefit of an existing insurance policy, consider naming the Presbyterian Homes Foundation as the beneficiary of all or part of the proceeds. To do so, contact your insurance carrier and complete a change of beneficiary form naming "Presbyterian Homes Foundation, Inc."

OUTRIGHT GIFT

If you own a fully paid, existing life insurance policy that you no longer need, you may want to consider donating the policy to the Presbyterian Homes Foundation. You benefit from an income tax charitable deduction for approximately the cash surrender value of the policy. We generally liquidate donated policies immediately and use the proceeds as you designate.
